RC Feiock is internationally recognized for his expertise in local government, sustainability, and local democratic institutions. He was the founding director of the FSU Local Governance Lab. He served as editor of *Public Administration Review* the leading journal in public administration 2013-2017. He is Director of Local Governance Research LLC, where he leads a team of scholars in publishing policy research and data analysis, training, and applied research.

Professor Feiock received his B.A. degree from Pennsylvania State University, and his M.P.A. and Ph.D. from the University of Kansas. He is a recipient of the American Political Science Association's Herbert Kaufman best paper award, the William E. and Frederick C. Mosher Award for the best article published in *Public Administration Review*, the Manning J. Dauer Award for research and service from the Florida Political Science Association, the Donald C. Stone Award for career contributions to the field of intergovernmental management from the American Society for Public Administration, the Marshall Dimock Award for the best lead article published in *Public Administration Review*, and the APSA Daniel Elazar Distinguished Federalism Scholar Award. From 2015 to 2018 he served on the U.S. Environmental Protection Agency, Board of Scientific Counselors HSC. He was elected as a fellow of the National Academy of Public Administration in 2014. He served as major professor for forty-five Ph.D. dissertations and received the Florida State University Graduate Faculty Mentor Award.
